### FIRST PUBLIC HEARING - EMERGENCY SALES TAX LEVY

At 11:00 a.m. President David K. Smith called the first public hearing regarding the Emergency Sales Tax Levy to order in the courthouse second floor meeting room noting the purpose of the public hearings is to obtain input from the public regarding an increase of sales tax in Gallia County by one quarter of one percent (0.25%) as advertised. Noting this is the first of two Public Hearings, the second to be held January 10, 2019 at 11 a.m. in the second floor meeting room of the Gallia County courthouse. In attendance: President David K. Smith; Vice President Brent Saunders; Commissioner Harold G. Montgomery; County Administrator Karen Sprague; Anette L. Brown, Clerk of the Board; Sheriff Matthew D. Champlin; Prosecutor Jason D. Holdren; Assistant Prosecutor Randy Dupree; Treasurer, Steve McGhee; 911/EMA Director, Sherry Daines; 911/EMS Deputy Director Keith Wilson; Recorder Roger Walker; Gallipolis City Commissioner Tony Gallagher; Gallipolis City Manager Eugene Greene and Dean Wright, Gallipolis Tribune Reporter. Commissioner Saunders noted his concern are the increased costs for operation of law enforcement & courts and the counties reduced revenue in the County General Fund. Sheriff Matthew D. Champlin presented statistics on the cost of corrections and inmate population over the past three years. The Commission President Smith noted the Sheriff's expenditures have increased by almost \$900,000 from 2015 to 2018 and that the jail contract service line item where out of county housing of prisoners is paid has more than tripled from 2015 to 2018. Commissioners also noted the revenues for the county general fund have not increased at the same rate as expenditures due to a significant loss in various revenue streams from the State of Ohio over the past and future years such as MCO Sales Tax, Defense of Indigent Reimbursement,

Undivided Local Government Fund and Public Utility Real Estate Taxes along with the additional costs to the County General Fund that Gallia County has encountered in funding both Law Enforcement and the Courts due in large part to the opioid crisis. Commissioner Montgomery noted this sales tax is for the county general fund operating expenses, not specifically for law enforcement, noting all departments are stressed. Commissioner's also noted Gallia County is the only one of the remaining surrounding Ohio counties at seven (7) percent sales tax, all other surrounding counties are at 7.25% sales tax. Gallipolis City Commissioner Tony Gallagher spoke as a citizen of Gallia County in support of the sales tax increase to help fund the services of the county and Gallipolis City Manager Gene Greene noted his support as well. Commissioner Montgomery further noted the County has some departments that receive funding that are not mandated to be funded by the County, such as OSU Extension Office (which is our 4-H programming) and Gallia County Soil & Water Conservation District. Commissioner Montgomery stated the Gallia County Commission takes great pride in funding those departments because historically agriculture has been the backbone of our county and we've been very supportive and want to continue to do that. Commissioner Montgomery noted that 4-H is important in the development of our youth in keeping them away from drugs and into something positive. County Administrator Sprague noted the Extension and Soil & Water Departments had not had an increase in funding for several years. No opposition was received at the hearing.

### **RE-ORGANIZATION MEETING**

At 1:00 p.m. on January 3, 2019 as advertised, the Commissioners met for the re-organization meeting as required by the Ohio Revised Code Section 305.05 on or before the second Monday of January.
